1. **Appointees shall furnish the following certificates:-**
  - i) A Medical fitness certificate from the Medical Authority concerned to whom, reference will be made by the Registry;
  - ii) Attested copies of all the certificates/testimonials, in support date of birth and educational qualifications etc., to be furnished at the time of joining, by each appointee. Original certificates are also required to be shown at the time of Joining;
  - iii) Two certificates, issued by a two Gazetted Officers to the effect that he bears a good moral character;
  - iv) A certificate to the effect that he has not entered into bigamy (applicable in case of married appointee(s) only);
2. Appointment is subject to verification of character and antecedents of the appointee(s);
3. The appointees will remain on probation for a period of two years from the date of his appointment. However, their service/appointment is liable to be terminated at any time without any notice, if their work and conduct is not found satisfactory;

4. The appointee(s) shall have to join the duty within a fortnight from the dispatch of this Office Order, failing which the offer of appointment shall be deemed to have been withdrawn.
5. The inter-se-seniority of the above appointee(s) shall be determined in accordance with the roster maintained for the purpose.


